Message from the President

"Transnational Education" was the title of a report published by the British Council for a meeting that took place in London during the British Presidency in June 2013, just before the G7 summit. The meeting was attended by the Rectors and the *Presidents of the most important Universities not* only of the G7 countries, but of the G20 also. The reason for the meeting was to address the issues faced by Universities that decide to open a branch campus in an offshore location. This mainly concerns UK, US and Australian Universities, who for some years now have adopted a strategy to attract local students in their overseas campuses. One of the main topics under discussion was how to ensure the same quality of education as in the "parent" University, the enrollment of the Faculty, the involvement of the local Education Authorities in devising the academic curricula etc. I was in the position to create quite a stir when I described the paradigm of Venice International University, which has adopted a completely different approach. Instead of exporting knowledge to subsidiaries abroad. we decided to attract Universities from all over the world to Venice (an international city by definition, perfectly suited for studying and a natural laboratory for analyzing environmental problems), in a communal Campus where these Universities address together and on a level footing the issues of the new globalized era. The comments that were made following my speech showed that there was a strong interest in our Association and during the ensuing debate, I was able to describe in detail how it functions. And no one could point out a model similar to that of VIU anywhere else in the world. This is the backdrop against which I feel the need to

express my deepest gratitude towards the Founders of VIU for having had the intuition, over twenty years ago, of such a groundbreaking model, still unique today. In particular, I would like to convey a heartfelt thanks to the first President of VIU, former President of the Italian Republic Carlo Azeglio Ciampi, who sadly passed away in September 2016. I am also particularly grateful to the "founding fathers" of VIU for their visionary decision to embark on this adventure: the Province of Venice (now the Metroplotitan City of Venice), owners of the Island of San Servolo where VIU has its Campus; the Fondazione di Venezia; and the initial group of five Universities who pioneered this unique model: the two Venetian Universities Ca' Foscari and IUAV, Duke University in the US, LMU in Germany and UAB in Spain.

I also want to thank all the Rectors of the Universities who have since joined, and those who have taken office during these past twenty years, for their extraordinary contribution towards the growth of our activities. In the course of 2016, the prestigious University KU Leuven in Belgium became the latest addition to our Association. The Dean, Professor Carlo Giupponi, has ensured the development and success of all our academic programs: he deserves a very special applause for his outlook and dedication.

The members of the Governing Bodies - the Assembly, the Board of Directors and the Academic Council have committed themselves to introduce new tracks for PhD Programs in important fields of study. But everyone (the Governors, Deans, Professors, students and staff of VIU) has contributed towards the promotion of our Association in Italy and throughout the world. This was done through a growth in our activities that could rely on the great potential of such a unique formula. As far as the local territory is concerned, VIU has taken part in numerous important events in the City of Venice: every year we are involved with the Art and Architecture Biennale, and we figure at the top of the Biennale Billboard of University partners at the entrance of the Giardini.

VIU has also organized its own cultural events. In 2016, I would like to mention a specially designed exhibition by Chinese master Qin Feng on the Island of San Giorgio Maggiore, which culminated with a performance by the artist in the Refectory in a stunning dialogue with Paolo Veronese's Wedding at Cana. VIU also co-organized a very special Retrospective by the great Chinese artist Han Meilin, in collaboration with Ca' Foscari University. These activities have contributed greatly towards the image of VIU and its appreciation by the local authorities: the City Council, the Metropolitan City of Venice and the Veneto Region have all recognized our contribution towards local cultural and academic activities. We would like to see an ever-increasing involvement of all our member Universities in our activities, in particular the Graduate Seminars, the Summer Schools and the new PhD Academies. We hope that other Universities from other geographical areas of the world not yet represented in VIU will want to join our Association, in particular the African and South American continents.

Lastly, I would like to mention that the VIU Alumni Network is a welcome addition to our activities, creating a bridge between the past, present and future Members of the Student body, the Faculty and the staff who have lived the "Global Experience" that VIU offers on the wonderful island of San Servolo, in the heart of the Venice lagoon.

Message from the Dean

Prof. Carlo Giupponi was elected Dean of VIU on 22 March 2016

I have had the pleasure of being involved in several VIU initiatives in the past and have contributed myself by organizing some conferences and seminars at VIU, where I benefitted from the professional support of the staff, the quality of the facilities and the beauty of the place. When the opportunity of becoming the new Dean of VIU emerged, I went back to those past experiences and found strong motivations for offering my competences for this new and challenging role. I found further incentives through the initial interactions with the colleagues from the eighteen Partner Institutions, whom I had the pleasure to meet in March. The two first – quite hectic – weeks of work at VIU, with dozens of meetings and brainstorming with the staff, three former deans and other colleagues collaborating in various ways with VIU just confirmed my initial feelings. VIU is a well-established organization, but I think we can easily identify several directions for consolidating the 20-year "VIU tradition" and *develop new ideas in partnership for the future:* efforts to move from 1-way or 2-way collaborations towards networks; further expansion of the partnership in geographical areas of strategic interest; improved collaboration between "local" universities and the other partners. Even if not entirely within VIU competencies, I would like also to develop actions to demonstrate that the concept of sustainability we teach to students and young scholars from all over the world is practically implemented on the island of San Servolo. I look forward to learning how at least some of those ideas can find concrete implementation in the coming years of collaboration with all those interested in the future of VIU.

The mission of VIU is to foster cooperation among VIU member institutions while facilitating the exchange of knowledge and ideas, by developing, promoting and organizing joint academic, research and training/capacity-building programs. VIU thereby contributes to, and is an integral part of the internationalization strategies of the member organizations.

Role of universities today

Universities today must play a strategic role in addressing the new global challenges: sustainable development, climate change and energy, food and water security, urban growth, welfare, ageing populations, the widening gap between rich and poor, global ethics, protection of tangible and intangible cultural heritage, human rights, equality, democratization, peace and conflict, global governance, cyber-security. Some of these critical global issues can be predicted, others arise unexpectedly and suddenly, and traditional training is not necessarily the best way to find solutions. Today's students need to develop different skills, must be able to work across disciplines, to react with great flexibility and a broad intellectual range.

Common campus in Venice

The common campus in Venice creates a sense of community that favors consensus building. Programs are drawn up collegially together, across disciplines, continents, languages and cultures. Students encounter a truly intercultural experience at VIU.

One of the advantages is to be in Venice, a living laboratory in a fragile environment with a remarkable cultural heritage where students and professors can directly experience and become aware of some of the common challenges.

Research triangle

Since its foundation in 1995, VIU has increasingly worked to promote the research triangle of stakeholders – industry, academia and government – through research projects, advanced training programs targeting professionals and policymakers, internships for university students and by inviting experts in chosen fields to recount their experience to VIU students.

Founded in 1995

Venice International University was founded on December 15, 1995 and is a legally recognized association operating under Italian private law. Its status as a non-profit association carries full patrimonial autonomy.

The Italian Ministry for University Education and Scientific and Technological Research formally recognized the Venice International University consortium as an international centre of higher education and research by Ministerial Decree on 23 October 1997.

Academic Programs

Globalization Program

Today's globalized world needs flexible minds, able to move across disciplines, capable of tackling challenges with innovative humanistic approaches while recognizing the importance of environmental and economic sustainability and natural and cultural heritage and understanding, while communicating and working with people from other cultures.

This program brings together talented, motivated students from the member universities in a truly multicultural, international and interdisciplinary environment. Students enjoy a powerful learning experience in which they develop their capacity for critical thinking, working across disciplines, creatively embracing new ideas.

The program provides a powerful learning experience in which students develop their capacity for critical thinking and creative problem solving. Students of the Globalization Program are thus more prepared for graduate studies and for careers in new and emerging fields.

Each term 140+ students (Bachelor or Master level) take part, choosing from a course offering of 20+ courses which are English-taught by visiting professors from the member universities and are recognized for credit.

Courses on three core topics are on offer every semester. There are two specialization tracks which are offered in alternate semesters.

Environmental Management and Sustainable Development







Intensive Graduate Activities

In 2015 the Board of Directors and the Academic Council decided to launch a new series of intensive graduate activities to fulfil the mission of facilitating the exchange of knowledge and ideas. A successful series of graduate activities is expected to result in the building and strengthening of networks on areas of shared interest within the consortium. The first of these were launched in 2016 and an intensification of the activities is programmed for 2017-2018.

PhD Academy

Venice International University holds two International PhD Academies each year. They are intensive training opportunities open to PhD candidates from the member universities of VIU. A PhD is the highest diploma awarded by universities in the world, and PhDs are naturally expected to take on major responsibilities in their professional life. Apart from the disciplinary scientific skills acquired during doctoral study and research, it is the ability to respond to the requirements of creativity, innovation and project management, and in addition the ability to step aside and examine scenarios from different perspectives, that produce the significant added value of a doctoral degree.

Whether they will work within or outside academia, PhDs must be able to develop a forward-looking vision of the challenges they have to face. The interdisciplinary approach of all VIU activities is adopted also in the PhD Academy, where the participants have the opportunity to meet their peers from all over the world, and to tackle transversal topics.

16 PhD students representing five VIU Member Universities took part in the first edition of the PhD Academy.

Science & Technology Studies (STS) is an interdisciplinary field, bringing together sociology, history, philosophy, sociology and related social science and humanities approaches. STS looks at science and technology (S&T) as a means of asking about the creation of facts, technological objects, and scientific knowledge, examining the ways in which S&T are embedded in social life. STS also provides a way to critically engage technical claims while retaining a researcher's own critical detachment from the claims of scientists and engineers. These claims can be far-reaching, engaging not only classical studies of technology, scientific laboratories, and production of scientific knowledge, but also examines issues around innovation, intellectual property, urban study, technological risks, intersection between art and science, and myriad other domains.



Graduate Seminars

These are thematic intensive seminars given in a concentrated period on subjects of universal interest, open to a broad spectrum of disciplines. They are suited to both Master's and PhD students and are open to candidates from all the VIU member institutions. Significant cooperation among departments in the member universities is expected.

FRAMING GLOBAL CHANGE AND GREEN ECONOMY IN THE SUSTAINABLE DEVELOPMENT GOALS September 12-16, 2016

The seminar was organized in collaboration with Ca' Foscari University of Venice, PhD in Science and Management of Climate Change. The school introduced the challenges within the newly introduced Sustainable Development Goals (SDGS) focusing on climate change challenges and green economy, referring to several specific SDGs. The aim of the school was to expose participants (PhD and graduate students) to principles and issues related to the SDGs and climate change, analyzing them from different points of view and providing tools and methodologies to apply among the others (i) economic and political tools, (ii) consumers' behaviour and demand role, (iii) innovation and technical aspects, (iv) indicators and evaluation techniques.

The school was organized as a combination of lectures and student activities from Monday morning to Friday. The participants were involved in lectures and in group work for practising and applying the tools and techniques presented.

Guglielmo Weber University of Padova In 2016 the Summer Institute on Ageing reached its 4th edition, and continues to provide students and early-career researchers with a multidisciplinary and rigorous understanding of the ageing process, ranging from some basic notions of the medical and epidemiological literature, to an extensive treatment of economics (pensions and retirement, ageing in society and intergenerational relationships) and social sciences (role of family networks). The program also addresses ICT, domotics and intelligent homes as a means to cope with ageing. 20 participants from eight countries took part in the 2016 Summer Institute which is open to PhD and post-doc scholars in economics, statistics, social sciences and medicine, and also professionals in the pharmaceutical and ageing care industries.

Responsible Capitalism: Strategy, Governance and Finance June 5-9, 2016 (1st edition)

Josh Whitford Columbia University The growing gap between rich and poor, the social and environmental side effects of production and a regulatory vacuum around multinational production networks have forced a new critical debate on our economic system. The Summer School explored sustainable capitalism from different angles: It will start by analyzing the ever more "postnational" constellation of capitalism, the potential roles and responsibilities of corporations in this changing societal context and sustainable corporate strategies. It addressed the integration of environmental, social and governance factors (ESG) in traditional financial portfolio management and the concept of responsible investment. The analysis of the key complications of sustainability also featured, namely the fact that it requires interdependent decisions and actions of multiple agents in a distributed environment. This circumstance alters both decision-making and the strategy implementation processes, and challenges the current governance and management conceptual toolkit available to scholars and practitioners. The program was established to promote research and education on the future of capitalism in the light of current research in economic sociology, strategy, organization theory, finance, history and philosophy.

The school will provide a unique opportunity for early-career researchers to interact with prominent scholars in the field and develop their own research ideas.

Applications were invited from PhD candidates, research master's students and post-doc researchers in Management, Strategy, Organization Theory, Finance, Economic Sociology, and related disciplines from universities worldwide.

14 graduate students attended, representing Italy, Spain, UK, Sweden.

Senior Advisors Caroline Bruzelius Duke University Donatella Calabi Università Iuav di Venezia Since 2012 Duke University, Università Iuav di Venezia, and Venice International University have collaborated in the field of historical and cultural visualization within the framework of the Visualizing Venice Summer Workshops. This workshop, held every summer at VIU, teaches a range of digital skills in digital mapping, 3D modeling from ground plans and photos, mobile application development, and time based media authorship to enable participants to engage historical questions with emerging digital tools. These technologies are taught through the use of a theme concerning the city of Venice which is different every year.

The case study adopted for training with a variety of technologies and applications during the summer 2016 edition was "The Ghetto of Venice", and coincided with the 500th anniversary of its foundation. During the first week of the course students learned techniques for digital production by drawing upon existing research materials provided by colleagues in the Visualizing Venice team. Each day, students learned about a different type of digital media production within the context of how that type of reconstruction is typically used in digital art and architectural history.

During the second week, the students worked collaboratively to create projects using the tools they had learned, with the goal of creating highquality, public-facing research products suitable for a general audience, as well as identifying potential areas to explore in their own future research. The final projects devised during the workshop used a combination of tools taught in the first week: SketchUp, Neatline, Omeka, WordPress, Google Earth, QGIS, RAW, Photoshop, and iMovie. Most of the projects also used combinations of 3D modeling and mapping to examine their research questions, and several mixed in data visualization as a third form of visual communication. The four projects created at the end of the workshop were:

_Mapping Food in the Ghetto: Practical Aspects and Jewish Identity. Preparing of food had an important role in Jewish community. Restriction of food may have had an impact on spaces in the Ghetto.

_The Changing Architectural Aspects of the Ghetto. Exploring the visual experience of the ghetto over time by exploring plans, elevations, and changing features.

_Movement of Jewish People and Goods into and within Venice Through Time. Visualizing ways in which Jewish movement of people and goods helped configure cultural and spatial community interaction.

_Ornament and Decoration in Venetian Synagogues. Using methods of material culture to reconstruct experience of Venetian synagogue spaces and explore the human scale of experience.

Environmental Management in a Changing World: Coping with Sea Level Rise 11-23 July 2016 (3rd edition)

William Pan Duke University The Nicholas School of the Environment (Duke University) and Venice International University offered the third edition of a Summer Program that provides training in key topics about the impact of sea level rise on coastal areas and cities. This course aimed to give students a broad perspective on the impact of sea level rise upon coastal areas from the social, economic and environmental point of view. Adaptation and mitigation strategies are analyzed and students are involved in discussions on critical management issues, developing their own critiquing concepts in a multidisciplinary framework. Participants in the 2016 edition, graduate students and working professionals from a range of disciplines and with an interest in environmental issues, learned the use of operational tools for coastal zone monitoring and management, and participated in four field campaigns aimed at exploring the most up-to-date techniques for coastal defense and protection. The interactive sessions in the digital technologies lab aimed at giving students a basic knowledge of some of the most-used software in environmental monitoring and management. The field campaigns used the Venetian lagoon to study the intertwined dynamics of human and natural systems. The site visits included: Ca' Bianca Land Reclamation Management Consortium, the salt marshes of the northern lagoon, Arsenale -





The goal is to have such programs fully integrated in VIU's core activities, so that they may further promote and develop the connections within the VIU community and maximize the pooling of knowledge capital across all VIU activities.

TeDIS Program on Innovation

TeDIS carries out training and research in the field of Innovation and Competitiveness in the Global Economy with particular attention to globalization processes of the world economy. TeDIS is conceived as:

_ a research context, being an active partner with respect to specific requests received from firms and public and private institutions.

Sustainable Logistics

The research focuses on transport, logistics and supply chain management both in local contexts and the global economy and aims at identifying new opportunities of economic growth at local and international levels based on innovative logistics services. The competitiveness of companies depends on their ability to generate value for customers and markets. Logistics can represent for SMEs a strategic leverage to compete on a global scale since it can ensure the delocalisation of production phases, higher services standards and closer relationships between enterprises and customers and suppliers. Value-creating activities are linked to the organization of integrated networks which depends on the planning, management and control of efficient and effective supply chains and logistics and transport systems. The interconnection of SMEs to logistic networks is fundamental in order to compete in terms of costs and service quality; SMEs need to be equipped with logistic interfaces that can reduce the information gap between them and specialized logistic operators. Competitiveness is determined by supply chains rather than single companies. The research develops knowledge and original and innovative approaches and methodologies which are the result of a clear-cut process of assessment of costs and benefits.

This area is developed in accordance with the EU 2020 Strategy and benefits from European funding programs. The aim is to provide innovative solutions and policy guidance for sustainable logistics that have become strategic for the competitiveness and success of productive and economic systems at any territorial level. An international network of researchers and institutions develop projects in the field of transport, logistics and supply chain management and involve countries of the so-called European MacroRegions; trans-national geographical areas, such as the Adriatic and Ionian, Alpine, Baltic Sea and Danube regions.

Novelog: New Cooperative Business Models and Guidance for Sustainable Logistics

Novelog is a triennial project (2015-2018) funded by the Horizon 2020 program. The scope of the project is to enable knowledge of freight distribution by providing guidance for implementing effective and sustainable policies and measures.

The partnership is led by the Centre for Research and Technology Hellas of the Hellenic Institute of Transport and includes 26 partners from 10 European countries: United Kingdom, Italy, Belgium, Poland, Spain, Austria, Greece, France, Denmark and Sweden. www.novelog.eu

Creativity and Innovation

Creativity design and Innovation are key elements for sustaining the competitive advantages of firms in a global economy. The growing demand for innovative products that respond to the discerning consumer's desire for aesthetics and quality has put creativity and design at the forefront as new drivers of innovative products and services. Italian companies that have been able to create a new link between craftsmanship and industrial production have become more competitive, especially those producing *Made in Italy* wares, such as the luxury sectors of fashion and design. The Italian knowhow has become the cornerstone for Italian growth.

A network of researchers from VIU member universities has involved SMEs in projects aimed at raising their awareness of how creativity and innovation may be the key to economic growth.

TeDIS research has two main perspectives: _Territory and industrial Districts: identifying the key factors that can sustain and foster the transformation of Italian industrial districts from manufacturing to creative clusters and how being part of a district can guarantee a competitive advantage to firms

_Firms and networks of firms: processes and strategies that firms put in place in order to innovate their products by investing in design and creativity. Innovation is the result of complex activities taking place inside single firms as well as in networks of firms. The research addresses how firms create value by using design and creativity to sustain product innovation. This group contributes regularly (since 2008) to discussions related to craftsmanship, design, globalization of SMEs, competitiveness on the www.firstdraft.it blog (in Italian).

Maker Faire Rome – The European Edition

For the third year, TeDIS received a commission of Innova Camera (Rome Chamber of Commerce) to contribute to the dissemination and supporting activities of the *Maker Faire*, specifically:

_ call for schools: identify and promote the best innovation projects developed by national and European high schools related to teaching technology.

_ new manufacturing: identification and selection of manufacturing SMEs that have renewed their processes and products with new technologies thereby enhancing their manufacturing capabilities.

Innovation in Public Administration

This branch of research analyzes the role of Information and Communication Technologies in supporting strategies and activities of the public institutions and how they can sustain relations among different institutions and the dialogue and interaction with citizens, enterprises and associations.





EU-CHINA LEVER FOR IPM DEMONSTRATION (EUCLID)

On September 8-9, 2016, VIU hosted the first annual meeting of the EUCLID project. EUCLID is a four-year Research and Innovation Action funded by the European Commission under Horizon 2020 (2015-2019). The overall objective is to secure food production for the increasing worldwide population while developing sustainable production methodologies to fight pests with an Integrated Pest Management approach (IPM), to be used in European and Chinese agriculture.

In the framework of the EUCLID project, VIU is leader of the dissemination work package which also includes consulation with policymakers, and carries out research on the socio-economic aspects related to consumer behavior and business plans (in cooperation with Ca' Foscari University of Venice).





Remediation of Old Landfills for Environmental sustainability and final Sink (ROLES)

The ROLES project aims to advance scientific research and technology related to old landfill remediation by using modern concepts such as environmental sustainability, stabilization and immobilization of long impacting hazardous substances, final sinks for elements and recovery of resources.

Experimental lab tests will be developed in both countries and a demonstrative full experiment will be carried out in China.

The ROLES project is funded by the Governments of Italy and China (MIUR – MOST) in the framework of the Italy-China projects of particular relevance 2016-2018 (*Progetto Grande Rilevanza Italia-Cina*).


24 Hours of Reality: The Road Forward: VIU Watch Party is on air!

SUMMER INSTITUTE ON AGEING June 6-10, 2016 (4th edition)

This activity was the first initiative of VIU to address the issue of Ageing populations, and is the foundation of the more articulated Ageing Program.

The Summer Institute provides students and early researchers with a multidisciplinary and rigorous understanding of the ageing process, ranging from some basic notions of the medical and epidemiological literature, to an extensive treatment of economics (pensions and retirement, ageing in society and intergenerational relationships) and social sciences (role of family networks). The program also addresses ICT, domotics and intelligent homes as a means to cope with ageing.

EUROPEAN ACADEMY FOR MEDICINE OF AGEING (EAMA) June 20-24, 2016

The European Academy for Medicine of Ageing is an Advanced Postgraduate Course in Geriatrics. The program aims to increase scientific, clinical, educational and managerial competences in medical gerontology.

In June 2016 Venice International University hosted the last session of the 9th edition of the EAMA Postgraduate Course In Geriatrics that gathers 25 attendants from all over Europe. This intensive study course composed of four sessions is addressed to faculty members of departments of geriatrics and academic teachers planning a career in geriatrics or in medical gerontology. The course is also open to junior potential academic staff working in other fields (internal medicine, subspecialties, biology) involving the ageing process and care of elderly people.

EFFECTIVE CARE OF OLDER PATIENTS WITH SWALLOWING DIFFICULTIES (PROFESSIONAL TRAINING COURSE) May 18-20, 2016

This 2nd EICA transnational teaching activity focused on "Effective care of older patients with swallowing difficulties" reviewed the evidencebased role of nutrition in older adults with swallowing difficulties.

The aim of the course is to educate early-career clinicians on state-of-the-art methods to expand their expertise on effective care strategies for older patients with swallowing difficulties. Beyond practical training, the Course is instrumental for participants to strengthen their clinical skills and collaborative network, providing a springboard to future leadership in the field of dysphagia. The course gathered 45 participants from 20 different countries and was awarded with 12 credits from the European Accreditation Council for Continuing Medical Education. This Course was organized by the European Interdisciplinary Council on Ageing (EICA), with collaboration of the European Society for Swallowing Disorders (ESSD) and the European Union Geriatric Medicine Society (EUGMS). The main partner of the training was Nestlé Health Science.

European Interdisciplinary Council on Ageing (EICA)

EICA is the first scientific organization in Europe specifically fostering the translation and dissemination of results from ageing research to various professional groups, policy makers, advanced education programs and the general public. Healthy and active ageing has turned out as being a cross cutting issue and also a major concern for individuals, health professionals and policy makers alike. Health in old age, and the maintenance of an active and independent life style is a high goal for each of us, but also contributes, for example, to economic prosperity through improving work participation, civil engagement and productivity making it crucial in the context of an ageing society and longer working lives.

The core motivation of EICA is therefore to put an interdisciplinary focus on daily life related questions concerning ageing, health and care and to foster adequate research, research analyses, education strategies and knowledge translation programs in Europe.

EICA is based at Venice International University and concentrates its activities on the San Servolo Island campus.

The VIU Ageing Program fosters and supports EICA in the organization of professional training activities.

Literature and Culture in the Ancient Mediterranean: Greece, Rome, and the Near East October 15-21, 2016

This advanced seminar is a two-year commitment for selected scholars in the Humanities, focusing on the origins and development of literary genres and literacy in Ancient Greece, Rome, and the Near East.

The aim of the program is firstly to investigate the relationship between themes, motifs and structures of the texts and/or of the myths involved, starting with the early examples of epic poetry and of wisdom and didactic literature; secondly to examine the processes involved in their transmission and preservation in both oral and written forms. A variety of issues concerning the history of literate cultures will also be reviewed, such as, for example, the textual traditions, the creation and organization of libraries, the classification of genres, and the relationship between literature and politics, and between literature and religion.

During the first session (November 23- December 4, 2015) the fellows identified a research project according to their scholarly interests and under the supervision of the faculty. 

In its second edition, the Summer School looks towards a sustainable future by bringing together young scholars from all over the world to discuss their ideas on the future of Capitalism from the microlevel of individual decision-making to the organizational and the societal level. Participants examine recent research from a broad set of disciplines. They will work on their ability to engage in the transdisciplinary discourse which is required for the development of innovative answers to grand sustainability challenges.

Academic Programs | Summer School | Summer Institute on Ageing: Global Ageing, Vulnerability and Disability June 5-10, 2017

The VIU Summer Institute on Ageing provides participants with a thorough understanding of the ageing process, offering notions of the medical and epidemiological recent literature to the socio-economic advances in this research area; enhances the multidisciplinary approach for researchers who work on ageing; provides "hands on" experience on the micro data-sets; increases the mobility and the inter-connectivity of PhD students, researchers, teaching staff and policy makers, hence favoring the creation of research networks.

Academic Programs | Summer School | Critical Infrastructure Resilience June 26-30, 2017

Coordinator: Erdem Ergin, University of TorVergata

In its first edition, the summer school on Critical Infrastructure Resilience brings together academics and professional experts to discuss an emerging topic with a pragmatic and scientific approach. The city of Venice will be used as a case-study and students will learn first-hand how to identify a critical infrastructure, assess its risk, develop resilience strategies and devise ways to apply them. The course consists of a mix of theoretical knowledge, case studies/projects and hands-on exercises, and will provide the participants with tools to analyze a system and its components, to prioritize connectivity, assess risk, and develop resilience strategies. These techniques can be applied to various fields and at various scales, from city scale to a global supply chain.

<u>Academic Programs | Summer School |</u> <u>Macroeconomics, Growth, and the Environment</u> July 2-8, 2017

The summer school is organized in cooperation with the European Association of Environmental and Resource Economists (EAERE) and Fondazione Eni Enrico Mattei (FEEM). Some of the most pressing environmental and resource problems – including climate change, deforestation, urban air pollution – are closely related to economic growth. Environmental policies have macroeconomic impacts. The aim of the 2017 Summer School is to provide tools and methods to study the intersection between macroeconomics, economic growth, and the environment.

TEN Program | Summer Training Course | Circular Economy: Policies and Practices July 3-5, 2017

This training course is meant to provide civil servants (public administrations) and professionals (utilities and firms) with an overview on the EU Circular Economy policies and practices as well as with a practical guide for their implementation at national, regional and local level. High-level international experts/ practitioners will present case studies/best practices related to, among the others: resource management, SME's support, behavioral change, legal and economic instruments.

The intensive program offered by the Summer School in oriental languages (ÜLO) intends to train students from different nationalities in ancient and modern oriental languages (Akkadian, Classical Hebrew, Modern Hebrew, Aramaic, classical Arabic, modern Arabic, old Persian, Persian, Armenian, Georgian, Coptic, classical Ethiopian, Syriac, Old Church Slavonic). While it is often difficult to open courses in rare languages at every university, the ÜLO allows the grouping of a sufficient number of students for the opening of such courses.

Academic Programs | Graduate Seminar | Understanding and Managing Climate Change: Coping with Sea Level Rise July 10-22, 2017

Coordinator: Sonia Silvestri, Duke University

The Graduate Seminar gives students a broad perspective on the impact of Climate Change and Sea Level Rise upon coastal areas from the social, economic and environmental points of view. Causes and consequences of global warming, and its impact on the state of the oceans and internal seas will be addressed and discussed, and changes in the hydrological cycle will be examined. Using data and models to explore future scenarios, the impact of sea level rise on coastal morphology, ecosystems, water resources, population and health will be presented and discussed.

The Autumn School focuses on urban and countryside communes, first forms of protoparliaments (like Etats Généraux in France), Orders of Knighthood, universities and other self-governing and autonomous societies in this period. The main school themes are political practices: public deliberation, voting, selection by lot, direct political participation, as well as republican notions in the texts written before 1500 A.D.: virtus, res publica, libertas and dignitas. Medieval republicanism will be discussed also in its connection to the past and to the future.

TeDIS Program |Project | Novelog ongoing in 2017

The NOVELOG project focuses on the enabling of knowledge and understanding of freight distribution and service trips by providing guidance for implementing effective and sustainable policies and measures. This guidance will support the choice of the most optimal and applicable solutions for urban freight and service transport and will facilitate stakeholder collaboration and the development, field testing and transfer of best governance and business models.

<u>TEN Program | Project | EUCLID EU-China Lever</u> for IPM Demonstration Ongoing in 2017

EUCLID is a four-year Research and Innovation Action funded by the European Commission under Horizon 2020. The overall objective is to secure food production for the increasing worldwide population while developing sustainable production methodologies to fight pests with an Integrated Pest Management approach (IPM), to be used in European and Chinese agriculture.

TeDIS Program |Project | Peripheral Access ongoing in 2017

Peripheral areas such as rural, remotely located or border regions make up 93 percent of the EU territory. These scarcely populated regions are all facing similar challenges: poor public transport connections, small budgets, demographic change and high levels of unsustainable, exclusive and costly private car use. Peripheral Access will analyze this situation in detail and derive concrete action plans and implement innovative pilot actions in three fields of action that represent key success factors for sustainable mobility: multimodality and integrated transport; enhanced use of intelligent communication technology and intelligent technology system; and better cooperation through transport associations and cross-border marketing. The results will benefit public transport users, planners and decision makers and will stimulate changes in mobility behavior.

TeDIS Program |Project | SUPAIR – Sustainable Ports in the Adriatic-Ionian Region Starting in 2017

It is a project co-financed by the Adriatic-Ionian Programme INTERREG V-B Transnational 2014-2020.
