# European Parliament's legislative proposal to the European Commission on the right to disconnect

Currently there is no EU-level legal framework directly defining and regulating the right for a worker to be able to disengage from work and refrain from engaging in work-related electronic communications, such as emails or other messages, during non-work hours.. The Working Time Directive (2003/88/EC), however, refers to a number of rights that indirectly relate to similar issues. At its January 2021 plenary meeting the European Parliament adopted the report with 472 votes in favour, 126 against and 83 abstentions. Parliament's Employment and Social Affairs Committee prepared the proposal (rapporteur Alex Agius Saliba (S&D, Malta).) accompanied by a wide consultation of stakeholders. It aims to reaffirm the right of no professional solicitation outside working time with full respect for working time legislation and working time provisions in collective agreements and contractual arrangements. This is a very timely initiative in the context of the ongoing digital transformation of the world of work that has been accelerated through the coronavirus lockdown measures. In her political guidelines, Commission President Ursula von der Leyen committed to responding to any Parliament legislative initiative with a legislative act, in full respect of the proportionality, subsidiarity and better law-making principles.
