Claudia Sandei is (Full) Professor of Company Law at the School of Law of the University of Padova and Director of Innovation and Technology Law Lab (ITLL), Co-founder and Managing Director of the Digital Law Network (DNL). Qualified Lawyer since 2008, after graduating in Law in Padova in 2003, Prof. Sandei got a Ph.D. at the University of Ferrara in 2009. Besides IT Law, her main areas of legal expertise include Corporate/Financial Law and IP Law. Author of three books on the impact of Technology on Company and Financial Law (online AGM; Initial Coin Offerings) and of many articles, in

2020 she has also acted as coeditor of a research book on The Law of Fintech (2020). Professor of EU Financial Regulation and Technology at the University of Hong Kong in 2022 and 2023, she also served as lecturer in many foreign Universities (Hannover, Varsavia, Budapest, Leeds, Nottingham, Barcelona, etc.), Member of the Academic Board of the PhD Programme in Corporate Law (Milan University). Member of the editorial board of some of the most important Law Journals (Rivista di diritto civile; Banca borsa e titoli di credito; Giurisprudenza Commerciale, Rivista di diritto societario; Int. Rev. of Law, Computers & Technology, Revista Rede de Direito Digital, Intelectual e Sociedade), Prof. Sandei has been in the Panel of the 2018 ELI Conference (Digital Law SIG) as one of the most renowned experts of Fintech in Italy and in 2021 in the Annual Conference of the European Law Institute (ELI Panel devoted to smart contract). In 2020 she has also been appointed member of the Expert Panel of the European Blockchain Observatory and Forum and served severally as expert for the EU Commission in Research Report on Company Law and Digitalization. Speaker at the UN Internet Governance Forum (IGF 2021-#111); TEDx Speaker. Member of the Human Inspired Technology Research Centre (HIT, Padova University).



Gabriele Nuzzo is Associate Professor of Commercial Law at the University of Milan-Bicocca. He graduated *summa cum laude* from the University of Palermo and earned a PhD in Commercial Law from University of Catania. From 2012 to 2017, he was researcher in Commercial Law and Maritime Law at University of Pisa. He is member of the Faculty Board of the PhD in Business for Society at University of Milan-Bicocca. He is Gastwissenschaftler at the Institut für ausländisches und internationales Privat- und Wirtschaftsrecht of the Ruprecht-Karls-Universität Heidelberg (Germany). In 2016, he was

Research Fellow at the City University of London. In 2022 he lectured "*Einführung in das italienische Gesellschaftsrecht*" at the Ruprecht-Karls-Universität Heidelberg (Germany). is a member of the Editorial Board of the Legal Journal "*Banca, borsa e titoli di credito*". He was appointed by the Italian Central Bank as member of the arbitration body for disputes between banks and customers ("*Arbitro Bancario e Finanziario*") in Bari (Italy). He was admitted to the Bar in 2007 and is qualified to practice before higher courts. He's active in consulting and pareristics, mainly in the field of corporate, banking and insolvency matters, as well as court advocacy in civil and commercial matters.



Alessandra Zanardo is an Associate Professor of Business Law at Ca' Foscari University and holds the National Scientific Habilitation (ASN) for the position of Full Professor. She graduated *summa cum laude* from the University of Trieste and earned a PhD in Business Law from Bocconi University in Milan. From 2007 to 2013, she was an Adjunct Professor of EU Business Law and Intellectual Property Law at the University of Verona, where she was also a postdoctoral fellow. Alessandra was Visiting Scholar and Professor at Queen Mary University of London, Chicago Kent-College of Law, Université Paris

Dauphine and, currently, at the University of Zaragoza. She has been a lawyer since 2006. She is a member of the INSOL International, ECGI and of the Italian Association of Business Law Professors and a member of the editorial board of several prestigious Italian law journals. She has published widely in the fields of company law, corporate governance and insolvency law in Italian, English, French and Spanish.



Andrea Minto is Associate Professor in Law and Regulation of Financial Markets at Ca' Foscari University and part-time Professor at the University of Stavanger - Business School, in Norway. Andrea works as Of Counsel at Annunziata&Conso Law Firm in Milan. Before that, he was an Associate at CHIOMENTI Law Firm, in the regulatory and financial law practice. Besides, he is Senior Policy Adviser and Researcher at the Deutsche Bundesbank Eurosystem, on topics such as FinTech, shadow banking and regulatory arbitration. Andrea's research interests reside at the intersection of Law,

Economics and Finance. He has written extensively on topics relating to economic law, European and comparative financial regulation, company and business law, FinTech and financial innovation.

Rüdiger Veil holds the Chair for Civil Law and Business Law at Ludwig-Maximilians-Universität, Munich. His main research areas are European corporate law and capital markets law. Rüdiger is a member of several working groups on corporate law and securities regulation. Since 2012 he has been a member of an academic working group advising the German Federal Ministry of Finance with regard to the reforms of EU financial markets law. He has served as an expert for the German and Russian parliament and has advised the German and Chinese governments on reforms of corporate law and capital

markets law. Rüdiger has published numerous books and articles in top ranked journals dealing with the regulation of market abuse, corporate disclosure, principles of investor protection and regulatory aspects of compliance and corporate governance, particularly from a comparative perspective.



Veerle Colaert holds the chair for financial law at KU Leuven University and is co-director of the KU Leuven Jan Ronse Institute for Company and Financial Law. She teaches the courses "European Financial Regulation", "European Banking and Investment Services Law", and "Bank-en Effectenrecht", next to an introductory course in commercial law. She leads the Business Law option of the KU Leuven LL.M programme and organises quarterly topical legal Clinics on European Financial Law for practitioners and LL.M students. She has published numerous articles on different aspects of financial regulation and is a regular

speaker at international and national conferences. Her main research interests relate to investor protection (MiFID, PRIIPs, IDD), sustainable finance, Banking Union, cross-sectoral financial regulation, and the interplay between different pieces of financial regulation. She is a member of the Belgian Resolution Authority and a member of the board of editors of the leading Belgian journal on company and financial law TRV/RPS. She was the Chair of the Securities and Markets Stakeholder Group advising ESMA from 2019 to 2024, after having been a member since 2016. She has served as a member of the Sanction Committee of the Belgian Financial Services and Markets Authority from 2016 to 2019.



Carlotta Rinaldo is Associate Professor of Commercial Law at the University of Padova and is Director of the Centro Interdisciplinare Linceo Giovani (Italian Young Academy) at the Accademia Nazionale dei Lincei in Rome. She holds a PhD from the Humboldt Universität zu Berlin (2016) and won the 2018 Award 'Antonio Feltrinelli Giovani' for legal sciences. She held visiting positions at the European University Institute (Fiesole), at the Graduiertenkolleg DynamInt (Humboldt Universität zu Berlin), and at the Max Planck Institut für ausländisches und internationales Privatrecht (Hamburg). She is a member of

the Editorial Board of prestigious Italian Law Journals, as well as a member of several international research projects. She has published three books and numerous articles on different aspects of company, insolvency, and financial law, particularly from a comparative perspective.



Alberto De Pra is an Associate Professor at the Padua University, where he teaches Commercial Law, Restructuring, Insolvency Law, and Competition Law. He also teaches European Competition Law at the European Doctorate in Law&Economics (EDLE). After graduating from the University of Bologna, Faculty of Law, he earned a Ph.D. degree in Law & Economics from Siena University. He has been visiting research fellow at the University of Cambridge (U.K.), Faculty of Law, and research fellow at the European University Institute in antitrust law. He is also head of the editorial board of the law review

“Giurisprudenza Commerciale” and member of the editorial board of the “RDS-Rivista di Diritto Societario Interno, Internazionale, Comunitario e Comparato”. He is a member of the Italian Bar and Academic Member of the European Corporate Governance Institute.
